Minutes of the regular public meeting of the Badger Town Council held Tuesday, November 12, 2019 at 6:30pm in Council Chambers.

Meeting called to order and chaired by Mayor Ed Card.

Mayor Card welcomed Natasha Beaton to Council. Ms Beaton was elected by acclamation during Nomination Day held October 15, 2019. Her "Oath of Office" was taken October 16, 2019 and is attached to the Minute Book.

Discussion:

- 1. Mayor Card welcomed Fire Chief Loder to the meeting. Fire Chief Loder presented his report.
- -Fire Chief advised that both pumpers require their annual Commercial Business Inspection which will be completed by Mr. Jason Hurley's Company.
- -They need two batteries for their AED units. We will receive one invoice for servicing and batteries for the units. Both are still operational.
- -Their request for funding will be resubmitted in the new year.
- -Their Chase the Ace fund raiser is doing good so far. They also have a 50/50 draw.
- -Fire Chief said that he was finalizing the receipts for the dinner for the Firemen's Ball.
- -They have one opening in their membership which they will deal with at a later date.

Discussion continued:

-Fire Chief said their members had a discussion about taking the red pumper when responding to incidents outside the town limits. Council has stipulated that the red pumper is to remain inside town limits. Fire Chief Loder said he did not recommend taking that unit outside town limits.

There being no further discussion Fire Chief Loder left the meeting at 6:42pm.

- 2. Mayor Card welcomed Ms Nicole Eddy, president of Badger Sports & Recreation to the meeting.
- -Ms Eddy discussed an issue with the back doors to the Stadium.
- -Discussion on the grant applied for to repair the roof at the Stadium. There has been no response to the application. If we need to reapply Ms Eddy said she could do the paperwork.
- -Discussion on constructing a dressing room upstairs. They have some volunteers willing to help with the work. The dressing rooms downstairs are not adequate for their needs. -Ms Eddy said that with the Senior's Christmas Social coming up she had four members that were willing to help. -Mr Eddy asked if the fryer in the kitchen in the community centre could be taken from there and put in the Stadium. Council will discuss this request and advise her of its decision.

Deputy Mayor Butt thanked Ms Eddy and her committee for their work he said there was positive feedback from the Halloween Party and other events they sponsor.

There being no further discussion Ms Eddy left the meeting at 6:55pm.

Discussion continued:

- 3. Mayor Card welcomed Mr Scott Luscombe to the meeting.
- -Scott advised that the check valve was changed on well #1 and working good.
- -chlorine levels for the water system are good.
- -Scott advised that they will be doing the waterline leak on the TCH tomorrow.
- -Scott advised that the old salt truck is not operational. With that salter filled you can do the town twice. He suggested maybe a 5 ton truck. Discussion on using the truck we got from Hydro with a salter in the back.
- -Scott said he had a few complaints from resident who didn't like snow in front of their properties when he was ploughing snow.
- Discussion on # 4 from the correspondence regarding the rehabilitation of three lift stations TCH; Main Street; Maple Street. Mayor explained that we applied for funding under the MCW; however, he was advised by the Department of Municipal Affairs that there wasn't a lot of funding in the program and suggested we apply under the ICIP which means the town would have to borrow its 10% share of the project. Scott felt we should have looked at changing the motors in the main lift station on Main Street because of the oversize motors in that unit. We can't change our application now to include another lift station. General discussion continued and it was agreed that the priority for repairing the units would be TCH Main Street Maple Street.
- -Discussion on the work done on Ted Patey Heritage Park and the good job done on the brick installation. Mayor Card advised that the bricks for that area was Pansy's idea.

There being no further discussion Mr. Luscombe left the meeting at 7:15pm.

4. Discussion on applying for the funding for the rehabilitation of the three lift stations under the Investing in Canada Infrastructure Program. The Town will have to borrow its 10% under this program. With the limited funding available under the Municipal Capital Works it is unlikely our application will be approved. The work on these lift stations needs to be done.

The Sports & Recreation Committee can use the fryer in the community centre.
- 2. Councillor Noseworthy has judges for the Santa Claus Parade and the Light Up for Christmas Contest.
- 3. Councillor Nicholas Blackwood will represent the Town at the VOCM Happy Tree on Thursday, November 14, 2019 at the Exploits Valley Mall.
