#### Discussion:

1. Discussion with Fire Chief Gus Loder. Mayor Card welcomed Fire Chief Loder to the meeting.

Fire Chief Loder gave his report.

The Fire Dept is on summer schedule now with meetings once per month on Thursday nights and practice is every second Wednesday night.

There are no issues with the equipment; however, we may have to replace some of the 2 ½" hoses soon.

The pick-up truck from Hydro needs some work. Several firemen volunteered to do the work but they are working now. We would just have to supply the materials for the repairs.

Chief Loder asked that the website be updated to show him as the Fire Chief.

Fire Chief advised that they will receive ten (10) bunkers suits from St. John's Regional Fire Dept from their surplus equipment. Fire Chief will pick them up next time he is in St. John's.

Fire Chief said he spoke to the sales representative for carbon monoxide detecting equipment. The individual units are around \$250.00. The unit for the building could be around \$3,500.00 to \$4,000.00. It is his understanding that OHS are still working on the details for the building units. We will check with OHS for an extension on the issues regarding the zamboni since it will be Christmas before we would be using the equipment.

There has been some issues with emergency vehicles finding these properties when responding to calls for assistance. We will have sign erected clearly marking where these are located.
- 6. Councillor Greene asked if something could be done to stop vehicles from using the area between #12 Maple Street and the multi-court area. Discussion held. It was suggested putting a post there. Scott Luscombe, Superintendent of Works will be advised of the issue.
- 7. Councillor Green asked about cleaning up the brush and alters between #93 and #97 Maple Street. Also, there is a tree growing up in front of the Fire Department sign on Maple Street. General discussion. Scott Luscombe, Superintendent of Works will be advised of the issue.
- 8. Mayor Card advised that Coady's Construction will be in town the first week of August to complete the repairs from last year. There are 5 or 6 waterline leaks that they have to repair.
- 9. Mayor Card advised that the Prime Consultant Agreement with Exploits Engineering in the amount of \$30,948.80 for project 17-MCW-18-00014 has been signed.
- 10. The Hydrant project has been sent to the Department of Municipal Affairs and Environment and should go to tender shortly.
- 11. Mayor said he spoke to Wilf Maloney from the Department of Municipal Affairs and Environment regarding a camera test on the sewer line installed by Coady's last summer. The project is expected to cost approximately \$5,000.00
- 12. Mayor Card said that he spoke to our MHA, Chris Tibbs regarding the resurfacing of the bridge on the TCH
