He stated that even though the motor and transmission may be good, the cab corners of the truck are deteriorating and shifting. The truck is now a safety liability. Council agreed that the truck should not be used by town employees anymore. Scott informed council that they are flushing lines. Overall the lines are in good condition. They will continue the process of line flushing for the next two weeks. Scott stated that once they are completed they will be done for the upcoming winter season
