The meeting was called to order and chaired by Mayor Butt at 6:30pm

Discussion:

- 1. Mayor Butt welcomed Harry Noel, Maintenance Employee to the meeting. Mr Noel gave his report.
- -The pump for the lift station on the TCH is still in St. John's. The contractor that installed the pump advised that the work is covered under warranty and when the pump is returned they will reinstall the unit.
- -The salter is good right now.
- -They have the zamboni back in operation. They are working on the ice surface at the Stadium which will depend on weather conditions.

Town Clerk/Manager advised that she spoke to the Central Office of the Department of Municipal and Provincial Affairs regarding training for our Codes of Conduct for Municipal Officials and Councillors which were adopted on January 10, 2023. We can do this training ourselves by everyone sitting down and going through the contents of the Code of Conducts. We have to ensure that everyone is aware and understands what is expected of them in their rolls as councillors or municipal officials.

Mayor Butt explained that he had discussions with Marathon Gold for a financial donation for our Come Home Year 60th Anniversary Celebrations and he was advised that there is no funding available for our request. They suggest we use our annual Community Allotment. The towns of Bishop's Falls and Badger were the only communities to receive funding outside the Community Allotment funding. Badger received \$5,000 to help repair the roof at the Stadium. Marathon Gold will renegotiate its community funding program in 2024/2025. We will complete some beatification projects this Spring with funding we have received from Marathon Gold.
