Meeting was called to order and chaired by Mayor Dennis Butt at 6:30pm.

## Discussion:

1. Mayor Butt welcomed Fire Chief Gord White to the meeting. Fire Chief White presented his report.

-Fire Chief advised that they are still waiting on Rock Solid Diesel to do the inspection on Pumper #2.

-The Fire Department has been fund raising to purchase pagers. Fire Chief advised that they received two donations one was \$3,500 and the other was \$1,000 and they had a block draw which took in \$4,080. He said the Department estimates they have enough funds to purchase eight pagers. They have forty pagers but six of those are not repairable. The new pagers are compatible with our system. He had a quote from HiTech Communication. They look after maintenance on our system. The pagers are \$550 plus \$100 charger plus \$25. Total cost is \$6,008,75.

There being no further discussion Fire Chief White left the meeting at 6:40pm

## **Discussion continued:**

- 2. Mayor Butt welcomed Mr Scott Luscombe, Superintendent of Works to the meeting. Mr Luscombe presented his report.
- -Scott advised that the water system and lift stations are working good.
- -The salt truck is working good again. Scott wasn't sure what happens with the truck.
- -Discussion on putting cold-patch in potholes on School Road and Maple Street. Scott advised that it is difficult keeping potholes filled when it's wet.

There being no further discussion Mr Luscombe left the meeting at 6:45pm

3. Mayor Butt welcomed Ms Kellie Kerpan, Manager of Culture and Community Outreach, Qalipu First Nation. Ms Kerpan made her presentation.

Ms Kerpan explained that they have been working on the Missing and Murdered Indigenous Women and Girls Commemoration Garden which she first approached Council with about a year and a half ago. Their Project is similar to the one in Corner Brook but on a smaller scale. Kellie is seeking the area known as Pope's Point for the Commemoration Garden in Badger. This area is connected with the history of indigenous people in our community. Ms Kerpan explained the significance of this area for their Project. She explained that this Project has to be completed in the 2023 construction season. Ms Kerpan would like to have this land donated to her group. She said the Garden could be used by everyone. Ms Kerpan required a letter of support from Council for her project. General discussion held. Ms Kerpan said that there is a group that follows Commemoration Gardens and it was felt this would attract tourist to our community.

There being no further discussion Ms Kerpan left the meeting at 7:00pm.

## **Discussion continued:**

Council continued the discussion on Ms Kerpan's presentation. Mayor Butt read the letter of support which Ms Kerpan provided for him to sign. Discussion on the options of leasing or donating the land. It was felt that leasing would still give the Town control of any possible changes to the use of the land and ownership going forward. This land is in the flood plain any development would have to meet the flood plain regulations. It was agreed that Council is in full support of the project and would make a provision for land.

- 5. Councillor Beaton is still working on quotes for hoodies and jackets. She hopes to have samples for the next meeting.
- 6. Discussion on next year 2023 being the Town's 60<sup>th</sup> anniversary of incorporation.
- 7. Discussion on ordering supplies for the games of chance for Badger Day. The supplier suggested we order early before there is a shortage of products available. It was agreed that Mayor Butt could go ahead an order supplies for the games of chance for Badger Day similar to last year's \$2,500.00. Discussion continued on music for the adult dance and planning for Badger Day 2022.
- 8. Discussion was held on having Exploits Engineering Consultants Ltd provide engineering services for the partial water and sewer replacement project on Sunset Drive and costs involved.
