Meeting called to order and chaired by Mayor Butt at 6:30pm

Discussion:

1. Mayor Butt welcomed Mr Ken Barrett to the meeting. Mr Barrett requested to attend the meeting to discuss the land at #26 Beothuck Street which is being leased to Qalipu First Nation for a Memorial Garden.

Mr Barrett said that since he lives next to the proposed development he was wondering the details of the proposed project. He was given pictures of the proposed Memorial Garden. He had concerns about what exactly would be happening at the site. It was explained that there were no building or structures being erected at the site. The development is a garden setting with seating space. The site will honor murdered and missing indigenous women and girls. Mr Barrett was concerned that this development would have an effect on his property value. It was suggested he could contact the Municipal Assessment Agency regarding his property value. He said that he is not antiindigenous he just wanted to know what was being developed next to his property. Mr Barrentt said he is experiencing some issues with young people using the area as a gathering place. Mayor Butt said that the lease will address issues of concern and should problems arise and the

Town will work with Qalipu First Nations to have the issues corrected. Mr Barrett was concerned because he saw the surveyor working in front of his property. Mayor Butt explained that they are still working on the survey and the Lease has not been signed to date. General discussion held.

Other Business:

- 1. Received from Central Newfoundland Waste Management was a copy of their 2023 Operating Budget. The disposal fees will increase from \$136.00 per tonne to \$140.00 with sorted materials going from \$55.00 per tonne to \$60.00. General discussion held.
- 2. Discussion on the siding that is missing from the Building. It was decided to contact local contractor, Chris Maher to have the issue repaired. The contractor withdrew his bid to replace the shingles on the building. Discussion held. It was agreed to wait until the Spring to do shingle work.
- 3. Councillor Young explained that she is working with Nicole Eddy on the finances for the Come Home Year Committee. Ms Eddy is responsible for the finances of the Badger Sports and Recreation Committee and has been assisting the Come Home Year Committee with its finances. In discussions with representatives of the Millertown CHYC it was suggested you need two treasurers. It was agreed that you must have two people sign off when counting any funds collected. With regards to the two treasurers it was agreed by all present that Councillor Ann Marie Young would be the second treasurer for the CHYC. Mayor Butt said that they are working with Marathon Gold regarding sponsorship for the 2023 60th Anniversary Come Home Year Celebrations. Discussion was held regarding the CHYC hiring the Navigator's for a concert during the Celebrations. The cost would be \$8,000 plus extras required by the Band which may amount to approximately \$2,000. Concern was expressed that the Town would be left having to pay the shortfall if sufficient funds are not raised to cover the expenses for the event. It was felt the Committee is on track with its fund raising plans to cover all cost incurred for events planned. Discussion continued.
