Meeting was called to order and chaired by Mayor Ed Card.

Discussion:

- 1. Mayor Card welcomed Mr Luscombe, Superintendent of Works, to the meeting. Mr Luscombe gave his report.
- -Water system is working good.
- -They will be repairing the leak on the TCH tomorrow morning. It was supposed to have been done on Monday past; however, there was a scheduling problem.
- -The island entrance to the community has been completed with the red stone and it looks great. Sides of the highway have been filled in and topsoil added.
- -Discussion on the weeds in the walkway to the Badger Monument. The area was sprayed and Scott said they would take out the weeds.
- -The new sign has been ordered for the Loggers' Way Walking Trail and should be ready by the end of the week.
- -The contractor advised that they are under the approved tender amount for the hydrant project. They are wondering if the Town wanted to put the hydrant on Earle Street. There is a hydrant on Earle Street near the end of the line. Discussion was held on putting a hydrant near #26 Badger Drive because that side of the highway is a dead end. The Town would have to cover any shortfall incurred in this matter. It was agreed we could apply for Gas Tax Funding to complete the installation.

- 3. The streetlight has been installed on Highland Crescent.
- 4. There is still a street sign missing for Main Street. Clerk was advised by the Superintendent of Works that all the street signs were in place. Also, the stop sign on Maple Street near Buchans Bridge needs to be replaced. There is also, a tree branch from property at corner of School Road and Church Road that is blocking motorist view of Church Road. Property owner will be contacted about having the branch removed.
