The meeting was called to order and chaired by Mayor Dennis Butt at 6:30pm

Discussion:

1. Mayor Butt welcomed Fire Chief White to the meeting and congratulated him on being appointed Fire Chief for the Town of Badger. Fire Chief White gave his report.

-Due to Covid restrictions meetings have been postponed. Fire Chief said that he instructed members to wear a mask when they come to the Fire Hall. Mayor said he would check on restrictions regarding meetings and practices. Members of the Fire Department were asked to have VaxPass verified at the Town Office. Fire Chief advised that he is verifying members VaxPass and keeping a record of those fully vaccinated.

-Two new members have been added to the Fire Department. They were Andrew Mercer and Tyron Paul.
-Fire Chief White advised they are still experiencing problems with Pumper #2. The unit is backfiring and there is a problem getting the speed up in the unit. Discussion held. It was agreed that Pumper #2 could be taken to Rock Solid Diesel to be checked; however, no work can commence until Council received a quote for the repairs required. Fire Chief will arrange to have Pump #2 taken to Grand Falls-Windsor.

-Fire Chief said that some members of the Fire Department want to take Pump #1 when responding to motor vehicle accident calls. Discussion held. It was explained that Pump #1 is for the protection of the residents of the Town and that is its first priority; therefore; the unit is not permitted to leave the community.

- -Scott advised that they put three floods on the ice surface at the Stadium today. He is hoping to be able to use the zamboni there tomorrow. Mayor said he appreciated their help in getting the ice surface ready at the Stadium.
- -Scott said all of the equipment is working.
- -There was a discussion on the pile of snow on the corner of Maple Street to Buchans Highway. It was agreed that Mayor Butt would have a discussion with the resident involved.
