Minutes of the regular public meeting of the Badger Town Council held Tuesday, July 13, 2021 at 6:30pm in Council Chambers.

Meeting called to order and chaired by Mayor Ed Card at 6:30pm.

Discussion:

- 1. Fire Chief Loder was unable to attend tonight's meeting.
- 2. Mayor Card welcomed Nicole Eddy, President of Badger Sports & Recreation to the meeting. Ms Eddy said that she wanted to discuss repairs to the Stadium roof. Ms Eddy said that the quote she received a couple of years ago is still good. The cost of the Project is \$9,875.00 plus HST. Badger Sports & Recreation will receive \$5,000 from Marathon Gold for the Stadium. They have approximately \$3,000 in their bank account. Ms Eddy asked if Badger Sports & Recreation could borrow \$3,000 from the money Council allotted for construction of dressing rooms. Ms Eddy said they are planning another fund raiser which will help with the Project. Discussion on replacing the skylights in the roof of the Stadium. General discussion held. Council will advise Ms Eddy of its decision. Ms Eddy said that her group will help with Badger Day and they will be serving food as well.

There being no further discussion. Ms Eddy left the meeting at 6:45pm

Discussion continued:

- 2. Mayor Card welcomed Mr Scott Luscombe, Superintendent of Works. Mr Luscombe gave his report.
- -No issues with the water system. The gauge has been replaced on the chlorination system.
- -Replaced hydraulic hose on the dump truck.
- -Students are working around the community. Councillors were asked that if they have anything they would like to see done to contact the Town Office.
- -Councillor Greene thanked Scott for his assistance with the National Indigenous Peoples Day celebrations. Councillor Greene represented the Town at the event because Councillor Noseworthy was unable to attend.

There being no further discussion Mr Luscombe left the meeting at 6:50pm

- 1. Discussion on permit request from #77 Maple Street to erect a steel building for a private garage on his property. There are two similar buildings erected in town. After some discussion and consulting the Town's Development Regulations all present agreed to issue the permit.
- 2. Discussion on Badger Brook First Nation request for the land acknowledgment and flying the Mi'Kmaq Flag. Councillor Greene felt that maybe Council could have a meeting with the elders in the community because there are more members than those in the Badger Brook First Nation Group. Discussion on a location for a flag pole. It was felt it maybe able to have it in the Garden Project that was discussed at an earlier meeting with Kellie Kerpan. We could also have a Flag for Council Chambers. Check will be made into the cost for the pole and Flag.
- 3. Scott repaired the basketballs nets and they are working good.

Correspondence:

1. Letter received from the Department of Municipal and Provincial Affairs advised that our request for Special Assistance funding for the work on the lift station was denied. The maximum amount for Special Assistance funding would be \$30,000. Discussion held regarding the outstanding invoice for Horwoods Limited. It was agreed to submit Capital Investment Plan for Gas Tax funding to complete the Project. Gas Tax Project #7-2020-7176 was approved from this work.

- 2. Information from MP Scott Simms office regarding the Canada Community Revitalization Fund. Applications must be submitted by July 23, 2021. Discussion on our Project to replace the shingles on the Town Centre Building as well as replacing entrance doors and install two heat pumps in the Community Centre. The Community Centre is the gathering place for the community and used for cultural events, seasonal events, etc. We were advised to submit separate applications for the Town Centre Building and the Stadium. Deputy Mayor Butt suggested maybe this would be a way to get funding to put an ice system in the Stadium. It was felt that since the deadline is 10 days away it maybe difficult to get the information together in such a short time. We do have the quotes for the Town Centre Building and the Stadium so these can be submitted.
- 3. Information received from Symone Hunt, Aboriginal Sport and Recreation Circle NL regarding funding programs. Some of this information is similar to that received from MP, Scott Simms office.
- 4. Consent Letter received from Newfoundland Power to continue routine maintenance on their infrastructure in our community. Letter will be signed and returned.
