- -Scott advised that the water system is working good; however, sometimes there is the sulphur smell from the water.
- -Scott said there was an issue with a motor from the main lift station on Main Street. He sent it to be assessed. He said he spoke to Paul Chafe and he said the motors shouldn't be breaking down.
- -Scott advised that they completed the asphalt patch on Maple Street near intersection to Memorial Drive. They have the area closed off tonight to allow the asphalt to set due to the warm temperatures. They will do the section of Second Avenue and section of Main Street as well as some smaller areas of town streets around the community.
- -Scott advised that the smell from the water seems worst when they flush the waterlines.

It is very difficult to get volunteers to help run the events. There were some issues that will have to be addressed in the planning for Badger Day 2019.
- 2. Mayor Card said that he received a call from a resident regarding wood trucks parked on the property of the former Helen's Restaurant that makes it difficult to see traffic coming into town from the TCH. Mayor said he spoke to the owner of the property and she doesn't want the trucks parking there either. This is private property and it was felt that "no parking" signs should be erected. It was felt that you only have to tow one vehicle and others will get the message. Discussion was also held on tractor trailers parking on both sides of the TCH when going to local coffee shop. One lane where they are parking is the turning lane from the TCH to Earle Street. The traffic congestion in the area is very dangerous.
