Discussion:

1. Discussion with Mr Harry Noel, Maintenance Man.

- -Harry advised that the town pick up truck needs to be replaced. They have been looking but haven't found anything.
- -Equipment is working good.
- There is no serge protector on the system. Harry explained that we are not getting power serges but the problem occurs when there is a power outage. It was agreed that we should contact Newfoundland Power and Newfoundland Hydro to see if there is anything they can do to help the town with this matter. We maybe able to use our gas tax funds to purchase serge protection equipment. General discussion continued. All the contractors regarding the new tank and pump house will be here next week and we need to get this issue corrected.
- -The lift stations are working good.
- -They have several waterline leaks to repair. The one on Badger Drive will have to wait until the water table goes down. It maybe July or August before they can do that leak. Local business man offered his excavator to do the repair. It was agreed we could rent the machine when we are ready to do the work.
