Minutes of the regular public meeting of the Badger Town Council held Tuesday, November 14, 2017 at 6:30pm in Council Chambers.

#### **Discussion:**

Mayor Card welcomed Mr Scott Luscombe,
 Superintendent of Works to the meeting.
 Mr Luscombe advised that the sewer system is working good.

They shocked the well again last week and there are no reports of a smell from the water up to today.

They have been working to get the equipment ready for Winter conditions and the alders have been cut around the playground.

Regarding the skating rink Scott suggested area near the pine tree by the ballfield, or on other side of the Stadium. There is a fire hydrant near these sites. This will be discussed later in the meeting.

Scott advised that there was a plug in the sewer main on Maple Street. They took a piece of 2" X 6" from the manhole. They had to hire a truck to have the plug removed. General discussion held on upgrades required at the sewerage treatment plant. Scott suggested that we should take a couple of streets per year and have the main sewer line flushed. Rob Kearley from our engineering firm Exploits Engineering and Consultants measuring area for water/sewer line extensions and installation of fire hydrants. Three areas on Maple Street and section on Third Avenue plus 12 fire hydrants.

Deputy Mayor Dennis Butt arrived at 6:45pm

#### **Discussion continued:**

Scott advised that no asphalt patching was done on Second Avenue because of timing, weather conditions and the availability of asphalt. We have to wait until Spring to complete this work.

There being no further discussion Mr Luscombe left the meeting at 6:47pm

#2. Mayor Card welcomed Fire Chief Gus Loder to the meeting. Fire Chief thanked Council for the invitation. Fire Chief Loder reported that the Fire Department responded to the following call to local school, two medical calls, one MVA and an false alarm MVA which was caused by a glitch in the 911 emergency reporting system. The Dept did receive a call to respond to a garage fire at Crook Lake cabin area which is outside our response area and they did not respond. They are looking into a couple of issues regarding their equipment. They have received the two new BA's that will replace the two old units which have to be returned to the supplier. Fire Chief will check on the process for returning the old units. They have the 911 decals placed on all the Fire Department vehicles. Fire Chief Loder said they are running into some issues with helmets, boots and gloves. Fire Chief would like to see an equipment replacement program for this type of items. General discussion on issue and the requirement to provide proper protective clothing for members responding to emergencies. Fire Chief will get a list of the equipment required for Council. Chief Loder said there is also a push to keep bunker gear clean. He will do some research on this matter. Fire Chief said they are still using the pager system because there is a delay of one to two minutes for firemen to receive the information on their cell phones. The cell phone system helps Fire Chief know how many firemen will be attend an emergency call or if a firemen is outside the community if they should return to assist with the call.

#### **Discussion continued:**

Fire Chief Loder invited councillors and their spouses to their annual Christmas Party being held on Saturday, December 16, 2017 at 9:00pm at the Community Centre. Fire Chief Loder will assist with security for our annual senior's Christmas Social being held on Friday, December 8<sup>th</sup>, 2017at 6:00pm

Discussion on complaints received from several residents regarding firemen speeding when they are responding to emergency calls. Fire Chief Loder said this is a standing item on the agenda every meeting and they will continue to do so. He said that members have been advised that if they are speeding and cause an accident it is totally their responsibility. It was agreed that this is not acceptable behavior. Chief will bring the issue back to the Fire Department.

Discussion on fire hydrants and how they are used when fighting fires.

Councillor Colleen Paul wondered if there was talks of forming a firettes group. Fire Chief said the Fire Department is not involved with firettes but there was some talk about the issue. The office they used in the past is still available to the group. It was felt that it would not be a requirement for a member of the firettes to have a spouse in the Fire Department.

Fire Chief said the Fire Dept will be having a barbecue at the Fire Hall this Saturday night and Council members were welcome to attend. It will be held in their meeting room. Fire Chief said the Fire Department has set up different committees to help with different issues regarding the operation of the Fire Department. General discussion.

There being no further discussion Fire Chief Loder left the meeting at 7:33pm.

- 4. The request was sent for the \$23,500 in extra funding for our TCH capital works project.
- 5. Request has been sent to the Department of Municipal Affairs and Environment for the extension of the TCH Project deferring start of the Project until Summer 2018.

- 6. Councillor Best attended the Central Newfoundland Waste Management meeting in Buchans and he advised that there were no changes in their Budget and this years fees will remain the same as 2017. He said that the west coast of the province will be coming into the system in 2018. General discussion.
- 7. Discussion on survey for purchase of land by resident on Maple Street from the Town. Discussion held. It was agreed that letter will be written to the resident advising that the survey has to be adjusted giving the Town fifteen feet (15') at the back of his property to allow the Town access to its land adjacent to the residents property.
- 8. Mayor Card advised that letter was written to resident of First Avenue concerning their land.
- 9. The emails accounts for councillors are now up and running.
- 10. Streetlights need to be repaired on Beothuck Street and in the playground.
- 11. Bus shelter has been repaired.
- 12. Mayor Card said he did speak to the subdivision developer and there is one resident willing to purchase land. General discussion on anything the town can do to work with the developer to get the project moving. The Town did sell the land to the developer.

## **Correspondence:**

1. Request received from resident seeking to purchase land behind another property on Sunset Drive. He is requesting the land to construct a house. The land in question belongs to Newfoundland Pine and Pulp. Discussion on this construction and if it would meet the requirements of our Municipal Plan. Building houses behind houses would not be permitted under our Plan. He would require a driveway off Sunset Drive. There was concern the distance from the driveway to the intersection on Buchans Highway. It was stated that the existing house would be removed when the new house is constructed. The issue was tabled to gather more information.
